#### MAEA Members:

It has been another very busy year in the MAEA office. Many initiatives have kept things moving and the work being done will help promote all programs.

It has been nice to hear from programs that they have received higher projected subsidy amounts for the 24-25 school year due to MAEA's work with the legislature with the final outcome of a 1.5 million dollar subsidy increase. MAEA will continue to share the funding needs of the field in the future.

Although there was no conference this fiscal year, there will be one early in 2024-2025. Planning for that conference has been underway since December of 2023. It takes much time and effort to plan an effective conference. We hope for great attendance and participation in October at Sunday River.

MAEA's Marketing Committee has worked hard to develop marketing images and videos for programs to use. The MAEA website at maineadulted.org has been completely redesigned and set up to show up faster in Google searches. The intent of the MAEA site is to get potential learners to your program sites as quickly as possible. The committee has offered some lunch and learn workshops and hopes to offer more in the near future. This year also marked the publication of the first adult education statewide magazine! The first distribution of copies started in February. More copies are set to be delivered to hubs in May.

MAEA's Advocacy group has also been very active this year. The Legislative Breakfast was very well attended in February. The group has also worked on ideas to present to superintendents and ways to continue to get the word out. This group will begin to brainstorm around AEFL Week soon. This week is always the third week in September and will be the 15th to the 21st.

MAEA's Corrections Committee worked on gathering information and investigating services at county jails. The corrections educational system functions within two levels - state and county. It is the goal of this committee to work towards a more aligned county educational level for all corrections facilities.

### **ACTION TEAM REPORTS**

#### Awards

Award forms will be sent out in May and then returned in early September. Award will be presented at the MAEA Conference in October.

#### Advocacy, Communication, and Legislative:

Projected subsidy amounts have been released for the 2024-2025 school year and reflect an increase of 1.5 million dollars to the total state subsidy. This is a huge victory for Maine Adult Education since a substantial increase to subsidy has not been seen in over ten years. MAEA will continue to work on subsidy equity in the upcoming year. There has also been work on funding for Workforce Navigators and College and Career Success Coordinators. This work will continue over the summer and into the fall. The Legislative Breakfast in February was very successful and had a great turnout. The committee wants to urge local directors to contact and invite in their local legislators.

#### Conference 2024:

Planning for the first fall conference in many years is underway! There was no conference in the 2023-2024 school year. The next conference will be held on October 24 and 25, 2024 at Sunday River in Newry, ME.

#### **Corrections:**

The Corrections Committee met on a monthly basis to gain support from around the state and assess what is currently offered in county facilities to inmates for educational purposes. The group hosted a meet and greet (via Zoom) for educators and corrections staff in January. The committee is working to define what is offered in each county jail and then compare that to a more standardized minimum offering for each facility. This work will continue into the next year.

#### **Director Support and Professional Development:**

This committee offered a book study using the book Trauma Stewardship as a follow up to the June conference. Eleven people completed the requirements of the book study. The committee will assess the desire for an additional group. Also offered were lunch and learn opportunities for marketing.

#### **Elections:**

MAEA members in Hubs 1, 2, 3, 8 and 9 will elect board members this year. Ballots were sent to all MAEA members in May and were returned before the Annual Meeting. In FY 25, board members for Hubs 4, 5, 6, and 7 will be elected.

#### Finance:

MAEA's conference in June of 2023 was a financial success which made the year a bit easier in terms of expending funds. MAEA continues to responsibly invest money as is possible and expend frugally each year. At this time, the financial state of MAEA is very good and initiatives will continue as planned.

#### Marketing:

MAEA has invested in a Google Ads campaign to help lead prospective learners to program websites as quickly and as efficiently as possible. The committee has also developed many video and image assets for programs to use. They will continue this work and additional professional development opportunities in the upcoming year.

#### Scholarship:

Dawn Wheeler from Merrymeeting Adult Education has taken the lead for awards and scholarships. Student and teacher scholarship applications were sent out in February and were scored in April and May. Scholarship winners will be announced by June 1, 2024
